Communications and Engagement Strategy

December 2018

1. Introduction

This communication and engagement strategy is designed to keep all Thruxton parish residents and businesses informed about the neighbourhood plan (NP).

In more formal terms, having a strategy will ensure the delivery of a "Consultation Statement" that meets with the definition of such a document as set out in Regulation 15 of the NP Regulations which make a consultation statement a statutory part of the package to be submitted for examination by an independent inspector towards the end of the process). The Regulations state:

15(2) In this regulation "consultation statement" means a document which –

- 1. (a) Contains details of the persons and bodies who were consulted about the proposed NP;
- 2. (b) Explains how they were consulted;
- 3. (c) Summarises the main issues and concerns raised by the persons consulted;

and

4. (d) Describes how these issues and concerns have been considered and, where

relevant, addressed in the proposed NP.

Thruxton parish is in north west Hampshire .

Thruxton Parish's Neighbourhood Plan (NP) covers all of the civil parish area and will span a similar timeframe as the TVBC Local Plan (LP) - up to 2029. It is anticipated that the NP will be renewed once the next TVBC Local Plan has been adopted and the requirements of the new LP are understood.

There are 276 dwellings in Thruxton Parish, with a population of 650 based on 2011 census data. One in five Thruxton parish residents are over 65 (2011 census), and 50% of respondents to the 2009 Parish Appraisal had lived in the village for more than 16 years.

The main cluster of housing is in Thruxton village. Other settlements within the Parish consist of Thruxton Down (to the west of the main village), a small number of houses on the Amesbury Road and the westerly side of Dauntsey Lane (to the east of the village) and a number of houses near the Parkhouse Cross (to the far west of the Parish), with the particular concentration of housing being at Thruxton Farm. It will be important to engage with those harder to reach within the community.

The Neighbourhood Plan Steering Group (NPSG) is leading the development of the Plan on behalf of Thruxton Parish Council, and is an advisory committee to the Parish Council. The NPSG has 12 members drawn from across the Parish, originally two being Parish Councillors but at December 2108 one, following a resignation from the Parish Council The NPSG reports to the Parish Council monthly.

The catalyst for Thruxton's NP came from an awareness of the requirement for additional housing in the South of England, coupled with speculative approaches to local farmers by developers seeking to acquire land. The Parish Council is keen to manage any building/development in the parish, informed by the views of residents, even though no housing has been specifically allocated to Thruxton Parish within the TVBC Local Plan (completed January 2016). The Local Plan has established that there is a need for 648 new houses to be built in Rural Northern Test Valley by 2029 – Thruxton is part of that area.

This communications and engagement strategy has been developed by the NPSG and identifies key stakeholders and interest groups in the parish. The aim is to engage as widely as possible to demonstrate effective and meaningful participation in the Neighbourhood Plan's development, and to help achieve a positive outcome at the referendum which concludes the NP process, planned for early late spring 2017 (anticipated late 2019 as of December 2018). It balances robustness with the NPSG's capacity to undertake consultation within the projected timeframe for completion of the NP. The strategy will fit into Thruxton Parish Council's wider communications activity and has been approved by the Parish Council.

2. Purpose of Communication and Engagement

For the adopted NP to reflect the views of those living and working in Thruxton Parish, it is important that all who wish to get involved have opportunities to be consulted on key issues, options and proposals, and to feed into the process of its development. A fundamental aim of the NP is to belong to those living and working in the area and the views of the community and stakeholders need to shape it as it is being developed.

Consultation runs throughout every stage of the NP process. Adopting an agreed communications and engagement strategy should make the most of existing capacity within the NPSG to effectively manage consultation requirements, both statutory and non-statutory. This is particularly important at pre-submission stage of consultation, which must accord with Regulation 14 of the NP Regulations. It is also essential for a robust Consultation Statement to accompany the final Plan to the Local Planning Authority (LPA) in accordance with the requirements of Regulation 15.

The NPSG will be responsible to the Parish Council for ensuring that this strategy is kept up to date, and for recording the outcomes of the different events, along with feeding these into the next stages of consultation. Whilst the programme is not "set in stone", it is designed to provide a firm foundation to build on for all stages of consultation.

3. Principles of Communication and Engagement

The NPSG will seek to be as inclusive as possible, providing all residents and workers in Thruxton parish with every opportunity to input into and help shape the NP. Specifically to:

- 1. ensure those that might be considered "harder to reach" are a focus of attention in engagement. This will include going out to residents in more remote parts of the parish and not to expect everyone to come to central events.
- 2. maximise the potential for volunteer involvement in the process;
- 3. make the most of all available channels of communication;
- plan consultation activities to deliver the best out comes for the NP;
- 5. engage those with any concerns about the policies in the NP to keep them informed and involved

The following channels of communication and engagement will be used to implement the programme:

i. Thruxton Parish Newsletter

The Thruxton Times is the monthly newsletter circulated to all households in the parish (except during January and August). This provides regular updates and highlights meetings or other community events/issues. In the months prior to consultation events, the newsletter will also contain details of times and venues. Additional information can be sent out with the Thruxton Times as required. Contact details for the chair of the NPSC are available in the newsletter.

ii. Thruxton Parish Website – NP Page

The website is regularly updated and contains a specific page for the Neighbourhood Plan. This is regularly updated and contains information about the NP and process. It will provide on going information, event notifications, consultation results and draft documents as they are produced.

iii. Facebook

The Thruxton Village Facebook Page is monitored by the NPSC and information posted when appropriate. Feedback can be obtained and questions can be answered.

N.B.

Consultation events and working group meetings will be advertised in all of the communication channels. Residents will be encouraged to participate and volunteers sought to support the process.

iv. Notice Boards

There are notice boards in the Parish which are regularly viewed by the community for village updates, including information on the NP. Information provided through notice boards will include details of events and give the link to the website.

v. Kimpton, Fyfield and Thruxton Primary School (a primary school for three parishes, including Thruxton).

The school is a focus point for part of the community and engagement will follow liaison with the headteacher as to what is appropriate in the circumstances of a shared school.

vi. Community groups and "harder to reach" residents

It is important that the NP is not solely village focussed. Outlying areas, Parkhouse Cross and Dauntsey Lane will be targeted with door-knocking during major consultation rounds.

The NPSG already holds an extensive list of voluntary groups, clubs and associations in Thruxton Parish (see below) with whom to engage and this will be added to where necessary. Community groups are a good way of reaching people who might not usually respond to consultations. They can provide a forum for informal and relaxed discussion, leading to valuable input into the NP process.

x. Capturing wider parish issues

The NPSG will ensure that all issues raised through NP consultations and surveys which do not fall within the remit of the NP itself, will be referred back to the parish council.

NP policies must relate to land use only. A Village Design statement was prepared in 2006 and remains valid. Any decision in respect of other issues will be referred back to the parish council.
